**Memorandum of Association**

**Passed in General Body on ..... (New/Amended)**

- 1. Name of the Society:** — The name of the Society is JANTA VIDYA MANDIR GANPAT RAI RASIWASIA COLLEGE SOCIETY.
- 2. Registered Office of the Society:** — The Registered Office of the Society shall be situated at Ram Krishan Gupta Marg, Charkhi Dadri, District Bhiwani in the State of Haryana or at any other places as may be decided by the Governing Body from time to time.
- 3. Aims & Objects of The Society:** — The objects for which the Society is formed are :  
To provide the educational facilities for all kinds of education and other allied activities for the promotion of the education by running various colleges
- 4. Definitions:-** In these Bye-laws, unless the context otherwise requires:—
  - (a) The Society means “JANTA VIDYA MANDIR GANPAT RAI RASIWASIA COLLEGE SOCIETY, Charkhi Dadri”
  - (b) The Act means The Haryana Registration and Regulation of Societies Act, 2012 with amendments;
  - (c) The Rules means The Haryana Registration and Regulation of Societies Rules, 2012 with amendments;
  - (d) The Registered Office means the registered office of the Society situated in the State of Haryana at Ram Krishan Gupta Marg, Charkhi Dadri, District Bhiwani or the address where it is changed at any time;
  - (e) The Aims & objects / purposes means aims & objects / purposes of the Society as set out in Memorandum of Association / Bye-laws of the Society;
  - (f) The General Body means the General Body of the Society consisting of all members of the Society;
  - (g) The Governing Body means the Governing Body / Governing Council / Managing Committee / Executive Committee called by whatsoever name;
  - (h) The President means the President of the Society;
  - (i) The Vice President means the Vice President of the Society;

- (j) The General Secretary means the General Secretary or Secretary of the Society;
- (k) The Treasurer means the Treasurer of the Society;
- (m) The Institute or Institution means the institutions set up and run by the society;
- (n) The State Government means the State Government of Haryana;
- (o) The Bye-laws mean the Bye-laws of the Society comprising the constitution of the Society/ as well as its rules and regulations;
- (p) The Collegium means the Collegium of the Society i.e. an inter-mediate body in between the General Body and the Governing Body of the Society constituted as per the Act & Rules;
- (q) Returning Officer means the Returning Officer as appointed by the Governing Body for conducting elections or any other object or purpose of the Society.
- (r) He means he or she as the case may be;
- (s) The other words and expressions used in the Memorandum of Association and Bye-laws of the Society, but not defined herein above shall have the same meaning as assigned to them in the Act and Rules framed there under.

## 5. DECLARATION

- (a) The income and property of the society shall be applied solely towards the promotion of the objects of the society as set forth in the memorandum of association and no portion thereof shall be paid or transferred directly or indirectly, to the members of the society.
- (b) No member of the society, shall be appointed to any salaried office of the society, no remuneration shall be given by the society to any member except repayment of out of pocket expenses and interest on money lent or rent for premises/demise to the society.
- © The Association by its constitution is required to apply its profit, if any, or other income in promoting its object.
- (d) If upon the winding up or dissolution of the society there remain after satisfaction of all debts and liabilities any property whatever, the same shall not be paid to be or distributed among the members of the society, but shall be given or transferred to some other institution having objects similar to the objects of the society to be determined by similar to the objects of the society at or before the time dissolution.
- (e) The society cannot sell its property/properties what so ever in any manner and under any circumstances. Any dispute arise in the Society, the District Registrar will not be responsible that & dispute will be resolve by the members of the Society.
